Regarding the age group, respondents who are below 35 years is 36.51%, those between 35-45 years are 28.04% and above 45 years are 35.45%. With reference to the level of respondents it was found that 40.21% were lecturers, 46.56% were senior and 13.22% were associate professors or professors.

Statement "Students become self-driven and responsible as they track their individual achievements" has the mean value of 3.88.
